"Because Invest Hong Kong has such a wide range of contacts, they are in the perfect position in assisting businesses that need cloud communications services to contact us," he added, "More generally, by profiling companies like ours on their website and other media helpsus to enhance our market exposure via their network."

Founded in 2016, PaaSoo's services include one-time-passwords (OTPs) for online services companies, and alerts and a wide range of notifications for clients that may include low account balance, transaction, and even emergency situations. These can

"One of our China-based clients manufactures drones which are sold to markets around the world," Ng quoted an exampled. "A purchaser of one of these drones needs to set up an account and become authenticated. This company is connected with PaaSoo's cloud-based platform, which immediately generates and sends an OTP to authenticate the account. Remember, this client is a drone manufacturer, not a communications company. PaaSoo's platform allows the client to focus on their core business while relying on PaaSoo for instant connectivity."

Currently, PaaSoo has offices around the world, as well as in Hong Kong, which manages most of the Asia Pacific region. Ng sees Hong Kong's vibrant Fintech ecosystem as an important growth engine for the company, "There's a lot of pioneering work being done in Hong Kong in Fintech". The company is looking to expand not only by

partnering with more telecom providers, but also by becoming an omnichannel communications platform, covering all kinds of communication channels including social media. PaaSoo's plans for conversation portals and APIs will integrate with popular chat apps such as Whatsapp and Viber.

PaaSoo is also addressing the growing importance of protecting personal data around the world, making it harder for data handlers and communications companies. In Europe, for example, the 2018 General Data Protection Regulations (GDPR) imposed tough rules on the handling of customer data by companies anywhere in the world, and PaaSoo's legal teams across different jurisdiction ensure the company always complied to the latest regulations. In Hong Kong, the Office of the Communications Authority has recently introduced a SMS Sender Registration Scheme that will designate officially registered senders, and PaaSoo is now an officially recognised service provider under the scheme. Leveraging on Hong Kong's robust regulatory frameworks, PaaSoo is well-positioned to continue providing secure and compliant data and communications services to its global clients from its regional headquarters in Hong Kong.
